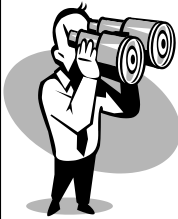

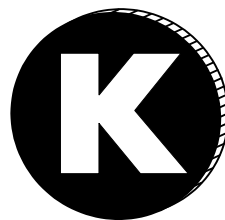

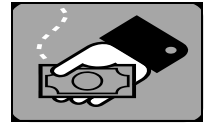
Unity Luncheon

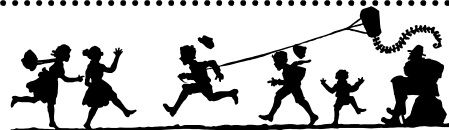
